DESCRIPTION OF WORK: Contractor proposes to furnish materials, tools, equipment and supplies and to perform labor in a substantial and workmanlike manner, which includes a description of materials to be used on the job, as follows: Re-roof hangar.

- Remove existing roofing down to purlins, dispose of old roofing, dump fee included.
- Pound or pull all existing fasteners. Clear off roof deck and inspect for structural soundness.
- If any dry rot is discovered, it will be replaced at \$85.00 per man hour + material (Time and Material Rate) It is impossible to determine severity of rot until the roof is removed.
- Install hook eave drip metal along gutter edges.
- Apply vinyl coated insulation / underlayment.
- Install Nu Ray Metal NRM-4000 metal roofing system with Kynar finish.
- Install gable and ridge flashings.
- Install Dek-Tight boots around penetrations.
- At the end of the day, job site will be left in a neat, professional manner.
- All roofing and related debris is hauled away and disposed of properly, and legally, leaving your premises clean.

#### SPECIAL NOTES:

\*All travel and lodging will be invoiced at cost when the project is completed. Costs are not included in this bid.

\*During the removal and installation of the roofing system, there may be areas where exposed ceilings exist and dust or debris may be able to filter into the building or attic space. Owner understands and agrees to prepare for this by covering items under exposed ceilings. Owner also recognize that debris may enter into the attic or in other areas inside the building is unavoidable and will not hold the Contractor responsible for that particular clean up.

\* Normal roofing operations may cause unavoidable noise and vibration. To prepare for roofing, the Contractor recommends that all wall or ceiling hangings be secured or removed during the roofing project.
